- There are now eight officers certified in commercial vehicle inspections
- May is the Safe Streets Initiative; part of this program is informing the public how unsafe it is







for those who stand at busy intersections asking for donations of money or food. To discourage that behaviour it is better to give funds to soup kitchens or food banks. While helping others is important, it is unsafe for people to engage in those activities that close to fast moving traffic.

- All OPP traffic vehicles have the automated licence plate readers; while licence plate renewals are free you are still obligated to ensure your licence plate is renewed you can check online at https://www.ontario.ca/page/licence-plate-renewals.
- Nonemergency issues, like traffic complaints, can be done online at www.opp.ca or by calling *677 (OPP). If people are aware of the different ways of reporting it will lessen the number of nonemergency calls being made through 9-1-1. All reports are investigated.
- Fraud is an ongoing issue. The OPP works closely with the Canadian Anti-Fraud Centre. The PNC Board hosted an Anti-Fraud talk on April 15th.
