Dear Ms. Willis:

We are pleased to offer you the Youth Intern Position with the Municipality of Powassan.

Your employment term is for a period of 52 weeks and will begin on June 17th, 2013. A 3 month probationary period will be required for this position, after which time a review will be completed by senior staff.

You will be responsible for assisting with the implementation of a marketing and branding strategy for the Municipality and for other tasks associated with promoting economic development within the community.

The hourly wage for this position will be \$14.00/hr, with 4% in lieu of vacation time paid out with each by-weekly pay period. You will be expected to work 35 hours a week, from 8:30 am to 4:30 pm Monday to Friday, with a 1 hour unpaid lunch. There will be evening committee meetings (at least once a month) that you will be required to attend. You may also be required to travel to meetings outside of the office or when organizing events. Mileage for personal vehicle use is paid at the rate of .48 cents per km.

By accepting this offer you agree to be bound by the laws, by-laws, policies and regulations that apply to the Municipality, including the confidentiality clause.
