TYPE OF PERMIT (Check the type of permit for which you are applying.)

RECREATIONAL

\$30/annual

For Settlement and Rural areas of the Municipality of Powassan. Fires must be contained and be at least 3m from any property line and 2m away from any combustible structure.

NON-RECREATIONAL

\$10/10 day, \$30/30 day

For Rural areas of the Municipality of Powassan only. For burn piles less than 2m in diameter and at least 20m from any building or property line and 6m from any other combustible object.
6:00pm – 1:00am

AGRICULTURAL

\$10/10 day

For rural areas of the Municipality of Powassan only. For the purpose of burning crop residue, vegetable matter or vegetation only. Must be at least 20m from any building or property line and 6m from any other combustible object. Sunrise-sunset.

FIRE WORKS

\$30/3 day

For rural areas of the Municipality of Powassan only. Consumer grade fireworks only. Must be at least 20m from any property line and 20m away from any combustible structure.
6:00pm – 1:00am

All slash and land clearing debris shall be piles or windrows, separated by a safe distance.

Permit may be revoked at any time due to weather conditions.

Permit not valid if wind exceeds 15km/h

The Permittee shall have at the burn site: A Spade shovel Two (2) gallon pails of water
 A Rake A charged garden hose
